

**RELEASE, WAIVER, AND HOLD HARMLESS AGREEMENT**

The undersigned Boarder, Horse Owner, Student, or Parent(s)/Legal Guardian(s) of same, (collectively "Client"), agrees to comply with the posted Barn Rules as well as the following terms and conditions:

- 1. **Assumption of Risk and Waiver:** Client understands and accepts the risks of engaging in equine activities, including, but not limited to, (i) the propensity of an equine to behave in a way that may result in injury or death to a person on or near it, (ii) the unpredictability of an equine's reaction to sound, movement, or unfamiliar object, person or animal, (iii) a collision with an object or another animal, (iv) the potential for a person participating in an equine activity to act in a negligent manner, to fail to control the equine or to not act within his or her ability, and (v) natural hazards, including surface and subsurface conditions. Client therefore agrees at all times to be responsible for his/her personal safety, remain financially responsible for his/her medical expenses, and waives his/her right to any claims arising from his/her participation in or observation of any equine activities or mere presence on the Paris Farms, LLC ("Facility") property.
- 2. **Release and Hold Harmless:** Client agrees to release and hold the Facility "Paris Farms LLC", Jafar Shah-Mirany MD, and Talie Shah-Mirany, their respective heirs, directors, members, subsidiaries, agents, officers, assigns, volunteers, employees, independent contractors, and affiliates, harmless for any illness, injury, death, damage, or other loss incurred.
- 3. **Governing Law:** The terms of this Agreement shall be governed by and construed in accordance with the laws of the State of Wisconsin.
- 4. **Attorneys' Fees:** Client agrees to reimburse Facility for any and all attorneys' fees and costs incurred by it in enforcing the terms of this Agreement and/or in defending or prosecuting any claims or causes of action involving, or in any way relating to, Client.
- 5. **Client Certification:** Client certifies that he/she has read this entire Agreement and understands, agrees, and intends on his/her own behalf, and on behalf of his/her heirs, agents, representatives, relatives, successors, and assigns, to be bound by all of the terms and conditions contained herein.
